**ANNEXURE – III**  
**PRIZE STRUCTURE OF WIN-WIN Weekly Lottery**  
**TERMS AND CONDITIONS**

- 1 Tickets will be printed in five series.
- 2 The maximum retail price of one ticket will be Rs.20/- only. One book of tickets will contain 25 tickets.
- 3 The first and second prizes will be drawn in full coming under the assured portion of prizes against the number of tickets sold. The remaining prizes will be under variable portion depending upon the sale of tickets.
- 4 The third prize will be determined by drawing the last five digits five times and extended to all sold tickets in all series.
- 5 The fourth prize will be determined by drawing the last four digits five times and extended to all sold tickets in all series.
- 6 The fifth prize will be determined by drawing the last three digits once and extended to all sold tickets in all series.
- 7 The sixth prize will be determined by drawing the last three digits once and extended to all sold tickets in all series.
- 8 The seventh prize will be determined by drawing the last three digits three times and extended to all sold tickets in all series.
- 9 The eighth prize will be determined by drawing the last two digits ten times and extended to all sold tickets in all series.
- 10 If any prize numbers in any category is repeated the same will be cancelled and redrawn.
- 11 Consolation prize of Rs.5000/- each will be given to the tickets in other four series of the 1<sup>st</sup> prize winning number.
- 12 An amount of Rs.5,00,000 (Five Lakh) from the cash prize of Ist prize and 10% from the prize amount of 2<sup>nd</sup> prize will be deducted and paid to the Agents concerned as Agents Commission on prize. An amount equivalent to 10% of the prize money on third and consolation prizes, 15% on 4<sup>th</sup> , 20% on 5<sup>th</sup> , 40% on 6<sup>th</sup> and 50% on 7<sup>th</sup> prizes will be given to the agents concerned as agents commission on prize from Government fund.

13 The Gold Prize attached to the 1st prize i.e., 50 Sovereign will be given as Gold in 999.9 purity provided by SBI. Disbursement of Gold will be through the designated branches of SBI in Kerala preferred by the Prizewinner.

- (i) Sale Tax, Income Tax and any other Taxes or Surcharge applicable on the Gold component of the First prize will be treated as part of the prize and paid from the Government Fund.

14 (i) Registered agents can purchase tickets at the following discounted rates.

- (ii) In addition to the above discount the agents will be allowed a special discount @ 10% by converting the agents commission on VIII prize. Hence the agents will not be eligible for agents commission on VIII prize separately.

- (iii) The highest eligible rate will be allowed for the entire tickets purchased by an agency. The above-mentioned discounted rate will be allowed based on the total purchase of tickets from the different District Lottery Offices. The dues or excess amount collected, if any will be adjusted in future claims or by exchange of tickets of the next lottery as the case may be from the office where the agency is registered.

15 Special incentive will be allowed to the agents who purchase maximum number of tickets as follows:-

If more than one agent purchases the same number of tickets the special incentive will be divided among them equally subject to the minimum amount of the next lowest purchaser.

16 Common incentive prize of Rs.1000/- each will be given to the agents in each district, who purchase maximum number of tickets of and above 1000 tickets. If more than one agent purchases the same number of tickets the amount will be divided among them equally.

17 The prize winning ticket should be surrendered within **30** days from the date of draw. The prize winners should record their names, address and signature in the space provided on the reverse of the tickets. The first prize winning ticket should be surrendered to the Director of State Lotteries in person or by insured registered post or through Nationalised/Scheduled banks /State or District Co-Operative banks supported with necessary documents.

18 The prizes of Rs.1,00,000/- and below may be claimed through the concerned District Lottery Offices/Directorate of State Lotteries. In the case of claimants from outside the state the claims should be submitted in the Directorate. Payment of prize money will be made only after ascertaining the genuineness of the tickets with the concerned counterfoils or by any other method as decided by the Director from time to time except in the case of 6<sup>th</sup> to 8<sup>th</sup> prizes.

- 19 Agents are allowed to collect prize tickets with prize money of Rs.5,000/- and below and pay the prize money to the prize winners themselves and thereafter claim prize money on behalf of the prize winners by exchange of tickets. The agents should clearly state whether the prized tickets are collected, and prize money already paid to the prize winners by them while presenting the same for payment.
- 20 Claims on mutilated or tampered tickets will be rejected outright. One ticket can win only one prize ie., the highest prize offered. Income Tax and surcharge etc; if any, will be deducted from the prize amount at source as laid down in the Finance Act.(Central).
- 21 Legal jurisdiction of this lottery will be at Thiruvananthapuram, Kerala.
